Membership Rules and Regulations

The membership of the Society is open to all interested in the field of photography. The aim of the Society is to help the members in every possible manner in its object to promotion of the art of photography.

There are following classes of members of the Society and the fees payable are as follows:

| Entrance fee (to be paid only once at the time of joining the Society) | Rs. 450 /- |
| E. Lifetime Associate Members: (Only spouses of Patrons, Life, and Honorary Members can apply) | Rs. 4500/- |
| F. Institutional Members | Rs. 3000 /- |
| Entrance Fee (to be paid only once at the time of joining the Society) | Rs. 450 /- |
| G. Honorary Members: The managing committee may at its discretion admit any person as an Honorary Member of the Society in recognition of his service to the art of Photography in general and service to the PSI in particular. | |
| H. Overseas Members: Any person residing outside India on onetime payment of US \$ 300/- or its equivalent in foreign exchange may be admitted as an Overseas Member. If such a member desires to receive communication from the Society will have to pay postage and other charges as may be decided by the managing committee. | |

The right to approve or reject any application for admission to the membership of the Society shall remain with the managing committee at all times.

The calendar year of the Society shall start on 1st April and end on the following 31st March.

Any person joining the Society as Ordinary, Ordinary Associate, or Institutional Member after 30th September will have to pay the fees for ½ (half) calendar year up to 31st March and also the fees for the next full year in advance. (i.e. fees for 1 ½ years).

Cheques and Demand Drafts should be made payable to “**The Photographic Society of India**” and crossed.

The annual subscription should be paid by the Ordinary, Ordinary Associate and Institutional Members before the 30th April of the calendar year regularly, failing which they will cease to be the members of the Society. It is not obligatory on the part of the Society to intimate the members about the payment of subscription.

The Ordinary Associate Member shall hold membership as long as he/she pays the annual subscription and the principal member remains the member of the Society. Lifetime Associate Member shall be allowed to continue as member, even after the principal member ceases to be the member of the Society, provided he/she pays half (1/2) of the prescribed subscription for Life membership and any other fees/deposits prevailing then i.e. at the time of payment.

Photocopies of valid Photo ID and Proof of Residence should be submitted along with the application form. The original documents should also be submitted for verification.

Whenever a member wishes to discontinue his/her membership of the Society, he/she must give one calendar month's notice before the date of expiry of the membership. Otherwise, six months fees shall be charged. Under no circumstances, any fees (or part thereof) shall be refunded to the member.

Activities/Facilities for the members (For details please contact the PSI office)

Weekly Programs: Free lectures, demonstrations, slide-shows, interactive sessions with eminent photographers and senior members, monthly photographic competitions, etc. are organized on **Fridays at 6.30 p.m.**

Photography Classes: The Society organizes **Basic** and **Advance** photography classes for the benefit of the members. These classes are conducted by eminent and experienced photographers.

Mega Outings: PSI regularly organizes photographic tours to various scenic locations in India.

Library: Library facility is available to the Patrons, Life, Honorary Members on payment of deposit of Rs.500/- and to the Ordinary Members on payment of deposit of Rs.1,000/-. One book and one magazine will be issued for a period of 14 days.

Studio: A well-equipped studio is available for members who wish to shoot indoors.

PSI Art Gallery: Members can avail of this facility for exhibiting their photographic work.

Other activities: Monthly Outings - Photographic Competitions / Exhibitions - Workshops.
